Inhibition (or Neutralization) of Antibodies

A few antibodies can be inhibited or neutralized by soluble antigens

- Anti-P1
- Lewis Antibodies
- Anti-Sd^a
- Anti-Chido/Rodgers (Ch/Rg)

Soluble antigen commercially available!

Inhibited by serum/plasma

Inhibited by urine!


Different antibodies can be inhibited/neutralized by different soluble substances.

Use inhibitions/neutralizations:


- Aids in identification
- Aids in rule-outs





Inhibition of Antibodies

Inhibition may allow us to rule out antibodies to common red cell antigens

- Tested in parallel with saline control to prove we didn't just dilute antibody
 - Saline control should be positive, inhibited plasma negative
- Inhibition may also help identify antibody**
- If antibody inhibition is successful, provides serologic evidence of antibody specificity



Example: Anti-Sd^a

- Sd^a is antigen of high prevalence
 - Anti-Sd^a reacts with most/all reagent red cells
- Anti-Sd^a characteristic agglutination:
 - mixed-field reactions: agglutinated clumps of cells against a background of free cells
 - Agglutinates refractile, shiny microscopically
- Soluble Sd^a blood group substance found in many body fluids including:
 - Human urine
 - Guinea pig urine




Anti-P1??




